

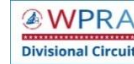

Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. **COVID-19 is extremely contagious** and is believed to spread mainly from person-to-person contact. As a result, federal, state and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

Sherburne County Agricultural Society, Sherburne County Fair, Sherburne County, Rise Up Riders Saddle Club, NBHA and Safe Haven Foster Shoppe as the governing, sanctioning organizations and sponsors have put in place preventative measures to reduce the spread of COVID-19; however the sanctioning organizations **cannot guarantee** that you or your child(ren) will not become infected with COVID-19 while attending or participating at the Cans for Kids event. Further, **attending this event could increase** your risk and your child(ren)'s risk of contracting COVID-19.
